Dear Parents/Carers,

YHA Boggle Hole Residential Visit 2019

This year our Year 5 children are being given the opportunity to attend YHA Boggle Hole for a 3 day residential. We have provisionally booked a 3 day visit from Monday 1st April to Wednesday 3rd April. The activity course is designed to build children's confidence and teamwork skills. YHA Boggle Hole is close to the Yorkshire Heritage Coast, providing plenty of opportunities for students to have dozens of enjoyable learning experiences!

Although this may seem a long way off, we need to confirm our booking by Friday 14th September. To secure a place for your child we require a non-refundable deposit of £30.00 by Wednesday 12th September 2018. The total cost of the residential visit will be approximately £140.00 per child (the final cost will be calculated once pupil numbers have been confirmed). The cost includes transport, full board and provision of activities and equipment. Please also note, all subsequent payments are also non-refundable.

We will be using Teachers2Parents (School Money) to manage the payments for this residential visit. The online link will be text and emailed to parents today when you will be able to log in and make your first payment (please note, we are unable to accept payments before this time).

If you wish for your child to attend, the £30.00 deposit needs paying before 12 noon on Wednesday 12th September 2018 otherwise we will assume your child will not be attending the residential and will remain in school on these days.

We recommend that you make regular payments via Teachers2Parents (School Money) as the remaining balance (approximately £110.00) is required no later than 12 noon on Friday 18th January 2019. If the full payment is not received by this date then your child will be unable to attend.

The charges may, in exceptional circumstances, be remitted in part at the discretion of the Head Teacher and Chair of Governors. Children whose parents are in receipt of support payments will be entitled to the remission of charges for board and lodging costs during residential school trips. Parents who think they may qualify for remission of charges should contact the Trinity Site Admin Office before Wednesday 12th September 2018.

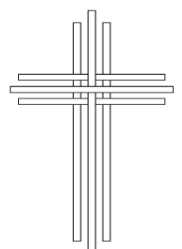
